COURSE: We will pass through woods, wet areas, small hills, and cross several roads. We will keep the roads to a minimum, but your horse needs to be road safe and can be ridden safely in open country. Crossing guards will be provided at road crossings.

TEAMS: 2 to 6 riders. Organize your own team or we can match you up with a team.

ATTIRE: hard hats and English or Western saddle required

COST: \$25.00 entry fee with applications postmarked by Saturday, June 18.

\$35.00 late entry fee after Sunday, June 19, 2010

COGGINS FROM 2010 REQUIRED WITH ENTRY BLANK

FOOD: Delicious hot sandwiches, snacks and drinks will be available. A plate lunch costing \$5.00 will include a hamburger/brat/hot dog chips, cookie, and a drink.

The object of the poker ride is to collect a total of five playing cards, which are given out at various check points throughout the trail. When finished with your ride, you will give all five cards to the PIT BOSS who will then register your hand accordingly. **There will be a grand prize for the rider that pulls the "Joker's Wild" card.** Prizes will be given to the best hands pertaining to the rules of poker. We will try to give everyone a gift.

DIRECTIONS: Highway 38 is closed for road construction. From I-94 exit at 7 Mile Rd and go east. There will be a stoplight at Hwy 38, a stop sign at Nicholson Rd, go over the river and turn right on Foley Rd. Go to the stop sign and turn left on 6 Mile Rd. The farm is located on the left side of the street after 1- 2 miles. If you go to the 4 way stop, you have gone ½ mile too far.
